

COVID-19 RIDER TO AGREEMENT AND LIABILITY RELEASE

This shall be a Rider to that certain Agreement and Liability Release executed simultaneously by the undersigned with SILVER WOODS FARM, LLC, a Michigan limited liability company ("Silver Woods"), owner of the stable and NICHOLS FARMS, LLC, a Michigan limited liability company ("Nichols Farms"), owner of the horses and operator of the stable (collectively referred to as "Stable"). In consideration of being allowed to enter the Stable's property, be near a horse, receive riding instruction or guidance, ride in a horse or tractor drawn wagon or hay ride, and/or ride horses (regardless of who owns them) on, near, or off of the Stable's Property and otherwise participate in events at the Stable, the undersigned, on my behalf and on behalf of my children (if children are included in the Agreement and Liability Release), acknowledge, appreciate, and agree that:

- i. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19.
- ii. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist for me and my children; and, I KNOWINGLY AND FREELY ASSUMES ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF SILVER WOODS FARM, LLC, NICHOLS FARMS, LLC, ANY MEMBER OF THE JOEY AND HEIDI NICHOLS FAMILY, AND THEIR RESPECTIVE EMPLOYEES, AGENTS, MEMBERS, MANAGERS, INSURERS, REPRESENTATIVES, HEIRS, ASSIGNS, AFFILIATED PERSONS, AND OTHERS ACTING ON THEIR BEHALF, AND ALL HORSE OWNERS ("RELEASEES") or others, and assumes full responsibility for my participation; and,
- iii. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, I observe any unusual or significant hazard during presence or participation at the Stable, I will remove myself from participation and bring such hazard to the attention of the nearest Stable official immediately; and,
- iv. I, HEREBY RELEASE, HOLD HARMLESS, AND AGREE TO INDEMNIFY AND DEFEND RELEASEES, WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law, arising in any manner out of Exhibitor's participation at the Stable and the contraction of an infectious disease by me, my children, or a third party.
